Note: Not all dogs are good candidates for Dog Park play and interaction with a wide cross section of dogs. Dog Park membership carries with it responsibilities to all Dog Park users and the public at large. If your dog is shy about meeting new people, children, or dogs, they might not be a good candidate for the Dog Park. In addition, Dog Park users must be able to maintain control over their dogs even when off leash. All dogs at the Dog Park should be responsive to their owner's calls.

Dog must have current vaccinations or titers (antibodies) for: Rabies, Distemper, Hepatitis, Para influenza, Parvovirus, Leptospirosis, and Bordetella (kennel cough). Dogs must also have stool sample test results for internal parasites. Members must sign a Release of Liability form upon registration.

#### **Dog Park Rules**

- **1.** Members must use own PIN to access park. DO NOT give PIN to or open the gate for non-members. If non-members use your access PIN, it may be suspended and your membership may be revoked.
- **2.** SCOOP THE POOP. Use the disposable bags available at the park. Park Ordinances require owner/handler clean up and properly dispose of waste left by their dog(s).
- **3.** Dogs must be kept on leash until they are in the dog park entrance and the gate has closed behind them. Do the reverse when leaving. For the safety of your pet as well as others, DO NOT keep your dog on leash while in the park.
- **4.** Dog owners/handlers must be physically capable of controlling their dog. All owners/handlers are required to remain inside the off-leash area and be in view of their dog(s) at all times. The limit is three (3) dogs per handler, per visit.
- **5.** Aggressive dogs are not permitted on the premises. Dogs exhibiting rough, aggressive or dangerous behavior must be leashed and removed by owner/handler immediately.
- **6.** Excessive barking is prohibited. Dogs barking excessively must be removed by owner/handler.
- **7.** All dogs must be current on all vaccinations. Vaccination expiration dates can be found on membership records.
- **8.** All dogs must be licensed by their respective municipality and display said license/tag while in the dog park. Non-residents must have the current rabies vaccine tag as well as a dog license tag issued by the governing body where they reside.
- **9.** Owners must fill any holes their dog(s) dig.
- **10.** The off-leash dog park is for recreational purposes for dogs supervised by their handlers. No other TYPE of animal or activities (i.e. hunting or other use) is allowed. No firearms, starting pistols are permitted.
- **11.** Absolutely no female dogs in heat or puppies under the age of six (6) months are allowed in the park.
- **12.** No smoking, food, alcoholic beverages, glass containers, strollers, or bicycles are allowed inside the dog park.
- **13.** Children under 15 years old must be accompanied and supervised closely by an adult at all times. It is recommended that small children not be brought into the off-leash area. Children are not permitted to run with or chase dogs.
- **14.** Users of the dog park do so at their own risk. Oak Lawn Park District is not liable for any injury or damage caused by any dog or person in this park. Owners and Users agree to assume full responsibility of any injuries, damages, or loss to themselves, their dogs or property, or any damage to other people or dogs connected with or associated with their use of the park.
- **15.** All users must immediately obey verbal or written orders of Park Employees. Please be reminded that failure to comply with park rules or to maintain the facility in a clean and orderly fashion will result in fines or temporary/permanent loss of park privileges.
- **16.** Only flying discs and tennis balls are allowed to be thrown inside the dog park.
- 17. All Park Ordinances apply. Enforced by Oak Lawn Park District and/or Oak Lawn Police Department.
- **18.** The Oak Lawn Park District reserves the right to revoke membership privileges.

## **Behavior Code of Conduct**

The Oak Lawn Park District is committed to providing an atmosphere of hospitality, civility and respect. We dedicate ourselves to the safety and well being of both staff and participants/patrons. All participants are expected to exhibit appropriate behavior at all times.

The following guidelines have been developed to help make our programs safe and enjoyable for all participants. Additional rules may be developed for specific programs as deemed necessary by staff.

You must be respectful to all participants, staff, and volunteers. Participants should follow program rules and take direction from staff.

### If a person is:

- ignoring directions and/or requests from staff
- using vulgarity
- making remarks of a personally destructive nature towards any other person (employee, volunteer or patron)
- restricting or preventing someone of free movement

#### If anyone's actions are:

- of a physical, spoken or written act of abuse
- of a violent nature
- considered harassment
- considered intimidation
- considered extortion

Immediate disciplinary action may be taken regardless if the act is deliberate, intentional or unintentional.

Appeals by the participant/patron should be directed to the Facility Manager. The manager will supply a current chain of command for the appeals process.
