MEMBERSHIP AGREEMENT

MEMBER RIGHTS - Upon acceptance of this application by the Oak Lawn Racquet Center (herein after referred to as "Management"), members shall be entitled to all rights and privileges of the indicated membership plan.

AGREEMENT - Member agrees to abide by all rules and regulations of the center. Management reserves the right to charge a penalty fee (equal to walk-on court time) to a member or members for not abiding by the rules when reserving courts. A "No-Show Fee" may be charged for failure to cancel a reservation in a timely manner.

MEMBER CHECK IN - All members MUST SCAN in with a valid membership card and pay any applicable fees before using the facility.

TERMINATION - The Oak Lawn Park District reserves the right to terminate any member where it deems it in the best interest of the Park District or the public. All member termination requests must be made in writing 30 days prior to termination date. Memberships run continuously.

CHECKS - Any check or draft payable to the Oak Lawn Park District Racquet Center that is not honored, in addition to the other rights it may have, management shall have the right to: (1) assess a service charge of \$30.00 for each check or draft so dishonored to reimburse the Park District for the cost of the collection, and (2) repeated offenses may make it necessary to terminate this agreement and collect the entire balance due for the remainder of the membership year.

CHANGE OF ADDRESS/EMAIL ADDRESS- It is imperative we have a correct email address as it is our primary means of communication with members. If there is any changes to your name, mailing address, or email; please notify the Racquet Center front desk or email racquet@olparks.com.

MEMBERSHIP DATES - Tennis memberships run from September 1st to August 31st of the next year. Racquetball members will be billed at the beginning of each month. Racquetball membership will be suspended if membership is not current or payment does not go through. Tennis, Wallyball, and Fitness members will pay membership fee in full at time of registration.
